## Invitation to Public Open House

Capstone Infrastructure Corporation invites you to learn more about our proposed Amherst 2 Wind Farm project and provide your comments, concerns, and feedback through an **interactive Virtual Open House** for the project.

Capstone is submitting a proposal to expand our existing Amherst Wind Farm in Cumberland County into Nova Scotia's Rate Based Procurement for new renewable energy supply that is currently underway. The proposed Amherst 2 Wind Project would have a generation capacity of approximately 60 MW and connect to the Nova Scotia Power grid. Please see reverse for a project area map.

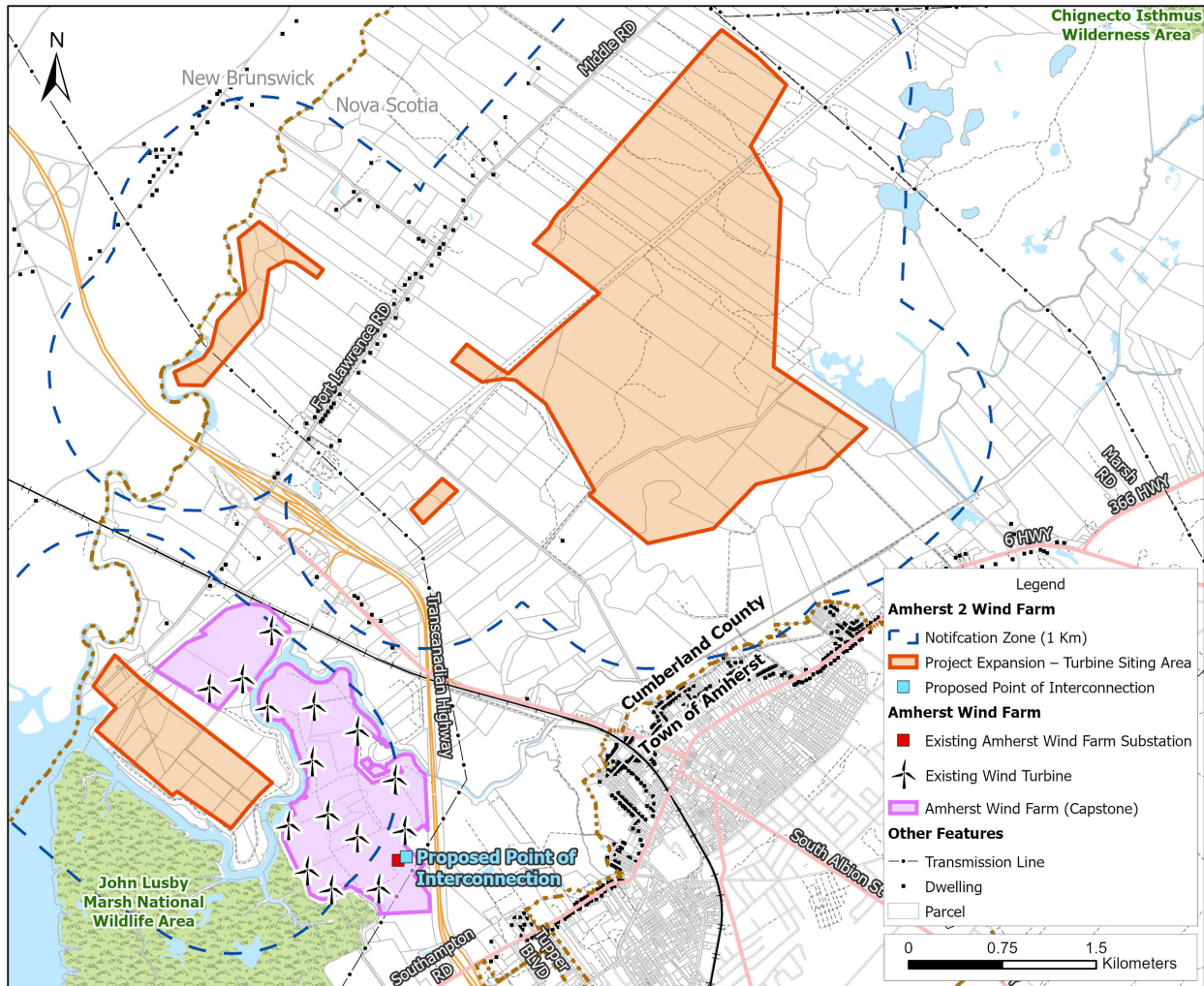
